There are no set rules or requirements on how much can be budgeted for this. However, you will need to show proof of payment to yourself, such as payroll, for that time, as well as a work-log showing the dates and hours worked on the project so it can be verified that the amount requested corresponds to actual hours spent working on the grant project.

If you started an LLC for the purpose of an agricultural enterprise, and were doing day-to-day management of it for the development of an agricultural/aquaculture product that would eventually be sold, then you use the age of your business.
